Assessment:

Through the process of talking to Dr. Jagani in my third informational interview, the importance of psychology became incredibly prevalent to my topic of study. In "Social Psychology" from Britannica School, the importance of psychology in a society as a whole has helped me define that psychology is important to build proper relationships with medical patients and their families.
